Typical Lazarus Alliance certification or attestation life-cycle

- 1 Stage 1 Gap:** This phase is used to determine an organization's readiness for the Stage 2 audit phase. Governance, Technology, Logistics and Human Resources undergo a gap assessment.
- 2 Readiness Option:** If it is determined that the organization is not yet ready for the Stage 2 audit, a gap report will be issued and remediation coordination will be optionally supported.
- 3 Stage 2:** Once an organization is ready for the Stage 2 audit, a full examination will get underway.
- 4 5 6 7** A full examination of the organization's Governance, Technology, Processing Facilities and Human Resource control implementations will proceed until an attestation or certification determination is reached.
- 8 Annual Monitoring:** Following a successful certification or attestation audit, the annual audit renewal cycle begins.
