The Citadel Has Been Breached - Addressing the Cyber Security Act of 2015

Congress & President Obama recently enacted a cybersecurity piece of legislation known as the "Cybersecurity Act of 2015" which is designed to ensure that public companies "provide a basic amount of information about the degree to which a firm is protecting the economic and financial interests of the firm from cyber-attacks."

In addition, the bill strengthens and prioritizes cybersecurity at publicly traded companies by encouraging the disclosure of cybersecurity expertise, or lack thereof, on corporate boards at these companies. This legislation requires companies to disclose – in their SEC filings – whether they have a director who is a "cybersecurity expert" – and if not, why having this expertise on the board isn't necessary because of other cybersecurity steps taken by the company.


The bill would require the SEC and the National Institute of Standards and Technology (NIST) to provide guidance on the qualifications necessary to be a cybersecurity expert.

Annual number of data breaches and exposed records in the United States from 2005 to 2015


